- TOPIC:** **Reasonable Expectations Doctrine: How far are the courts prepared to go?**
The reasonable expectations doctrine is a method of resolving ambiguous policy wording. The doctrine dictates that the policy be construed in a fashion consistent with the reasonable expectations of the parties. Though rooted in U.S. law, “reasonable expectations” has become well established in Canada. Recent case law in Ontario suggests that the courts may be prepared to at least consider expanding the application of the doctrine to those situations where policy wording is unambiguous. Our speaker will explore this interesting possibility and discuss this doctrine which all industry professionals can benefit from better understanding.
